Consent to the processing of personal data

In accordance with Articles 23, 24 of the Constitution of the Russian Federation, Federal Law of July 27, 2006 No. 152-FZ "On Personal Data", the Policy for the processing of personal data, posted on the website at: https://embrycare.ru/ (hereinafter referred to as the site), I, the subject of personal data, hereinafter referred to as the User, by sending/providing information when filling out forms and questionnaires on the site (hereinafter, each of them and all together the form, forms) and further when using the Site and / or its services, express full, unconditional and unequivocal Consent to the processing of my personal data (hereinafter - Consent) on the following terms:

- 1. Consent is issued to Limited Liability Company "Line of Care" (LLC "Line of Care", INN 7838119744, OGRN 1247800007652, address: Russian Federation, 190005, St. Petersburg, Fontanka River Embankment, Building 136, Letter A, Room 1-N, Office 2, Workplace 7
- 2. Consent is given for the processing of personal and other data specified by the User in the forms by filling in the relevant text fields and/or files attached to the forms, namely the following categories:
- last name, first name, patronymic, email address, telephone number, other information provided by the User of the website (including when filling out the application form), on the basis of which it is possible to identify him/her as the subject of personal data
 - Year, month, date and place of birth;
 - Information about marital status and family composition;
- Information about reproductive and general health, including information about medical examinations, the presence of chronic diseases, test results and doctors' opinions necessary to assess the possibility of participation in the program;
- Other information necessary for the proper assessment of the candidate's compliance with the medical and legal criteria for participation in the program
- data that are automatically transferred during browsing and visiting the website pages: IP address, cookie information, browser information, access time, address of the visited page, referrer (address of the previous page);
 - statistics about my IP addresses.
 - 3. Consent is given for the processing of personal data for the following purposes:
- providing access to the website, its content and/or services, to the functionality of the website/services, for website administration;
 - identification when sending applications and/or using the website services;
 - providing services, processing requests and applications;
 - establishing feedback, including sending notifications and requests;
 - confirming the completeness of the personal data provided;
 - collecting statistics by the Operator;
- improving the quality of the website and/or its service, the ease of use and the development of new services and services;

- conducting marketing (advertising) events, sending offers by the Operator and receiving them by the User for the promotion of the Operator's services on the market, including through direct contacts.

I confirm that I am aware and agree that for the above purposes, the Operator has the right to collect and use additional information, related to me, received during the user's access to the site, its content and/or services, or from third parties, and including data on technical means (including mobile devices) and methods of technological interaction with the site and/or its service (including the host IP address, the user's operating system type, browser type, geographic location, provider data, etc.), on the user's activity when using the site and/or its service, cookies, information on errors given to the user, downloaded files, videos, tools, as well as other data obtained in accordance with the methods established by the Personal Data Processing Policy; manage statistical information related to the functioning of the site and/or its service, as well as user information for the purposes of organizing the functioning and technical support of the site and/or its service and fulfilling the conditions of the legislation of the Russian Federation, and the Personal Data Processing Policy developed in accordance with it. 4. In the process of processing personal data, the Operator has the right to: collect, record, systematize, accumulate, store, clarify (update, change), extract, use, transfer (disseminate, provide, access), depersonalize, block, delete, destroy the User's personal data.

5. I hereby confirm that:

- 5.1. I consent to the processing of my personal data specified in paragraph 2 of this consent, by the persons specified in paragraph 1 of this consent, and also confirm that the Operator has explained the consequences of failure to provide personal data, in cases where the provision of such data is mandatory in accordance with federal law.
- 5.2. Informed of the possibility of revoking consent based on the provisions of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data" by personal appeal or sending a written request (including in the form of an electronic document signed with a simple electronic signature or an enhanced qualified electronic signature), addressed to the persons specified in paragraph 1 of the Consent, including informed of the right to revoke Consent for the purpose of terminating the processing by the person specified in paragraph 1 of the Consent of both all personal data specified in paragraph 2 of the Consent and separately biometric personal data (if such are requested by the Operator and provided by the User).
- 5.3. I have been informed that the persons specified in paragraph 1 of this Consent have the right to continue processing the User's personal data after receiving the revocation of the Consent, as well as after the expiration of the Consent, if there are grounds provided for in Part 2 of Article 9 of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data".
- 5.4. I agree to receive advertising and information materials and have been informed by the Operator of the possibility and procedure for refusing such.
- 6. The Consent comes into force from the moment it is sent and can be revoked by the User by sending a written statement in any form to the Operator at the email address hello@embrycare.ru or in another way that allows the fact of its receipt by the addressee to be clearly determined in accordance with the Personal Data Processing Policy.
- 7. The Consent is valid for an indefinite period until it is revoked by the User. The Consent shall expire on the date specified in the User's application for revocation of Consent to

the processing of PDn, but not earlier than the date following the date of actual receipt by the Operator of the revocation of Consent.

- 8. The date and time of formation, confirmation and sending of Consent shall be considered the moment of marking the relevant field (or clicking the relevant button) in the Form and/or clicking the Form send button on any page of the Site and/or its Service.
- 9. Guided by Part 4 of Article 9 of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data", I send it through a personal mobile device or personal computer by attaching it to a special form or by filling in the relevant fields of such form on the Site.
- 10. The User is informed that the Operator who issued the relevant order (consent) shall be responsible to him for the actions of the person processing his personal data on behalf of the Operator.
